All students (Management/NRI) whose names are enlisted in the **Eligible candidate list for institutional Stray Vacancy Round for Deemed Universities** displayed on the MCC website and are interested to take admission for vacant (surrendered) PG seats (**Annexure 01**) at constituent medical colleges of MGM Institute of Health Sciences (Deemed to be University) namely: MGM Medical College, Navi Mumbai AND MGM Medical College, Aurangabad, are hereby directed to act as follows:

- (A) **For Pre/Para Clinical seats** of both medical colleges (Anatomy, Physiology, Biochemistry, Pharmacology, Microbiology, Pathology, IHBT and Community Medicine): Seats will be filled on First Come First Served basis on November 30, 2022, December 1, 2022 and December 2, 2022 (on all 3 days from 9 am to 4 pm). Candidates may directly approach to deans office of the medical college where they wish to take admission (Navi Mumbai OR Aurangabad) with all original documents and tuition fee.
- (B) **For Anesthesia (Management) and Pediatrics (NRI) seats**: Admission counseling for these seats of both medical colleges will be held at MGM University Headquarter at Navi Mumbai. Candidates need to submit an email request on neetpg2022@mgmuhs.com email ID as per following schedule:

1. Only those students who remain present at reporting time and found to be registered with us through the Email registration process as mentioned above will be considered for counseling and admission.
2. Accordingly, a local merit list (MGMIHS Merit list) will be prepared for management seats & NRI Seats based on which admission process will be conducted after 3 pm on same day.
3. All those students who are eligible as per MCC/DGHS list but could not register through Email with MGMIHS and present themselves on the day of counseling will be considered in the end, if any seat is vacant.
4. If the vacant seats get filled completely midway, then the counseling process will be stopped immediately and remaining students present on that day will not be considered for admission counseling. All such remaining students will not have any claim for admission merely because they presented themselves for counseling.
5. Mere enlistment in the **Eligible Candidate list for Institutional Stray Vacancy Round for Deemed Universities** displayed on the MCC of DGHS website & submission of email to MGMIHS does not mean admission confirmation.
6. Admission will be confirmed only on verification of all original documents and payment of fees after the seat is allotted.
7. Regarding NRI Seats, the directions passed by the Hon'ble Supreme Court of India in W.P. (C) No.689/2017 dated 22.08.2017 in the case of, Consortium of Deemed universities in Karnataka (CODEUNIK) &Anr. Vs. UOI &Ors. should be followed.
8. Those candidates willing to take admission on NRI seats must report with all relevant documents on the day of counseling (For list of documents refer **Annexure 02**).
9. No cancellation is permitted for admission taken through Institutional Stray Vacancy Round.
10. Candidate (himself/herself) must be present for the Institutional Stray Vacancy Round. No proxy will be allowed under any circumstances. Along with students only one parent will be allowed inside the reporting venue.
11. Merit list wise candidates will be called for counseling. All candidates therefore, need to be alert and present in the counseling hall as their names may be called for counseling. University will not be responsible if students / parents remain absent on such occasion and due to which they miss the chance of counseling and subsequent admission.

12. The students are requested to bring with them all Original and two sets of self-attested Photocopies of all the documents (**Annexure 02**).
13. The students should pay the Tuition Fees (**Annexure 03**) of first year in the form of Demand Draft only. Demand Draft must be made in favor of "MGM Institute of Health Sciences" payable at Mumbai. Multiple DD's in different denominations are allowed in case a single DD of the total 1st year tuition fees is not available.
14. Fee payment through RTGS is permitted. Details will be provided only after the seat is allotted. Admission will be confirmed only after the receipt of fees in the institute's bank account.
15. NRI students must pay the annual tuition fee from his/her sponsorer's NRI Bank account only. **Fee payment through non sponsors account will not be allowed.**
16. Apart from tuition fees, University Eligibility fees and Other fees (Hostel fees, Mess fees, Library fees, Gymkhana fees, Security deposit and Miscellaneous charges) need to be paid later (**Annexure- 04**).
17. Due to limited parking capacity in the campus, students/parents will not be allowed to park their vehicles inside the campus.
18. Photocopy and Canteen facility is available in the campus.
19. Kindly be aware of the fake websites and the old notifications available through google search. Only the latest notifications available on official website of the University / Medical College need to be followed. Further refresh the pages before viewing the official website.
20. All original documents will be returned to the student after verification and granting of eligibility by the University at a later stage.
21. All candidates are informed that as the term has already started they need to join the college immediately after completing the admission formalities.

AGREEMENT

AGREEMENT is made at ... this ... day of ... between the Mahatma Gandhi Missions Institute of Health Sciences having its office at Sector 1, Kamothe, Navi Mumbai (hereinafter referred to as the Party of the First Part) and Miss/Mr. (Dr. - residing at (hereinafter referred to as the Party of the Second Part).

WHEREAS

1. The Party of the first part is the Mahatma Gandhi Missions Institute of Health Sciences, a deemed to be University registered under the University Grants Commission Act and established by the Mahatma Gandhi Mission Trust (MGM Trust), registered Public Charitable Trust. The Mahatma Gandhi Missions Institute of Health Sciences has 2 constituents Medical Colleges in Navi Mumbai and in Aurangabad.

2. The Party of the second part is a student who has taken admission and enrolled/ is desirous of enrolling in the course of (Degree) MD/MS/Diploma offered by the Colleges/Institutes, which are run and administered by the Party of the First part.

3. The party of second part on completion of the course of (Degree) MD/MS/Diploma will be qualified person to be employed to the post of Senior Resident/Tutor with the party of first part. The Party of the second part has agreed and undertaken to join the employment of the party of first part as a Senior Resident/Tutor and work with the party of the first part for a period of 1 year.

4. The party of the second part has also agreed to execute a Bond, Indemnity and Undertaking in relation to the employment etc. The party of the second part acknowledges, admits and undertakes that after the completion of the course of (Degree) MD/MS/Diploma, the party of the second part will join and continue to work with the party of the first part for a period of 1 year. The party of the second part will be paid salary.

6. The parties have now mutually decided to reduce the same in writing on the following terms and conditions:-

NOW IT IS AGREED BETWEEN THE PARTIES HERETO AS
FOLLOWS:

- (i) The party of the second part agrees to work with the party of the first part as a Senior Resident/Tutor at the ----- run and administered by the party of the first part at a pre defined monthly salary/stipend based on the MCI/Government norms.
- (ii) The party of the second part agrees, undertakes and is bound by the agreement, bond and undertaking to work for a total period of 1 year from the date the party of second part assumes charge of the said post. The said period may be extended for a further period from time to time as may be agreed upon. The party of the second part and the sureties have also executed the required bond, indemnity and undertaking.
- (iii) The party of the first part shall pay to the party of the second part a pre defined monthly salary/stipend based on the MCI/Government norms.
- (iv) The party of the first part will, as far as possible provide a suitable residential accommodation to the part of the second part free of cost.
- (v) The Party of the Second Part agrees and admits that the rural posting for specified duration will be compulsory. The place of posting will be purely at the discretion of the Dean/Management.
- (vi) The Party of the Second Part agrees and admits that all the original documents submitted to the institute at the time of admission and mark sheet, passing certificate and degree certificate of the course in which admitted (issued by University) will be in custody of -----Medical College, Hospital & Research Centre, till completion of the bond period of 1 years.
- (vii) The party of the second part will be entitled to leave as per the norms of MGMIHS.
- (viii) The party of the second part will devote the whole office or working time and shall work faithfully, sincerely, diligently and efficiently and to the best of her ability and make her best efforts to use her knowledge and skill in providing the best medical services and medical care to the patients.

- (ix) The party of the second part will diligently undertake and complete the administrative work related to the patients assigned to her/him. The party of second part will not divulge or disclose to anybody any medical case papers, examinations details, reports of any of the patients.
- (x) If the party of the second part resigns from service and terminates this agreement before the expiration of the said period of 1 year, she/he will be liable to pay to the party of the first part a sum of Rs 25,00,000/ - (Rupees Twenty-Five lacs only) as per the agreement, bond indemnity and undertaking.
- (xi) The party of the second part will not remain absent from the work without a prior intimation and without obtaining prior written permission of the Administrator of the hospital or in his absence of any other Director of the Hospital.

7. All disputes or difference pertaining to the subject matter of the this agreement or in respect of the employment of the party of the second part shall be referred to Arbitration.

1. That the student shall entitled to stipendiary benefit from the College as may be decided by the College and will not accept any employment or conduct any private practice while undergoing the course.

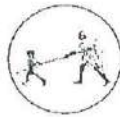
